## DEAN'S BI-WEEKLY MESSAGE

Dear USC Dentistry Community,

As you might have heard, the USC Office of the Provost has announced a few important updates in regards to our COVID-19 mitigation efforts. First, beginning May 3, students, faculty and staff who have been fully vaccinated (defined as: two weeks after your second dose of the Moderna or Pfizer vaccine or two weeks after your Johnson & Johnson vaccine) will no longer be

required to participate in weekly (or twice weekly for dental hygiene students) surveillance testing. You will, however, still be required to complete your Trojan Check every day to enter campus. If you have not yet been vaccinated or have submitted a personal declination to do so on your <a href="MySHR">MySHR</a>, you will still be required to test regularly for campus access.

Secondly, all students, faculty and staff are required to have either uploaded your vaccination records or personal declinations to your MySHR by June 1. If you received your vaccines at a USC Student Health or Keck Medicine of USC site, your MySHR account should be updated automatically, but you might want to double check just to be sure.

Finally, once the U.S. Food and Drug Administration grants full approval for these vaccines (expected to happen later this summer), all USC students, faculty and staff will be required to be vaccinated to participate in any oncampus activity — unless you have requested an exception due to disability or religious belief. These are some crucial steps to ensure we are able to resume life as usual on our campuses for the Fall 2021 trimester/semester.




